Appendix - Flow Down Terms: CallCabinet

1. **DEFINITIONS**

In this Appendix the following terms and expressions shall have the following meanings:

Third Party in the context of this Appendix means CallCabinet Corporation

Third Party Services means various services and applications, including the Third Party Software, provided by Supplier whereby the Reseller Client and/or end-user can record, store and retrieve audio files and related data, along with other related services as described on www.callcabinet.com, from time to time.

Third Party Software means the Third Party software specified in the Reseller Agreement, to be provided to the Reseller Client by Supplier via the Reseller pursuant to the Contract.

2. ORDER OF PRECEDENCE

In the event of any conflict or inconsistency between any of the provisions in the Contract and this Appendix, the provisions of this of this Appendix shall prevail.

3. USE

- 3.1. The Reseller shall not sell to the Reseller Client the Third Party Services outside of North America, the United Kingdom and the European Union without prior written approval from Supplier.
- 3.2. The Third Party Services are provided with an initial ninety (90) days rolling storage plan ("Initial Storage Plan"). The Initial Storage Plan will automatically purge call recordings at the end of the ninety (90) day period. In the event that Reseller wishes Supplier to retain call recordings for longer than ninety (90) days, then this must be pre agreed in writing and additional storage rates shall apply.

4. THIRD PARTY'S RIGHTS

Supplier is an authorised reseller of the Third Party Services, and, as such, cannot represent that the Third Party will continue to manufacture any particular item or model of product indefinitely or even for any specific period, and the Third Party Services shall, at all times, be subject to the Third Party's right to modify any of the specifications or characteristics of its products, to remove any element of the Third Party Services, and/or to cease manufacturing or supporting it.

5. LIMITATION OF LIABILITY

Supplier's liability in connection with the Third Party Services shall be limited to the 100% of the Charges paid by the Reseller in respect of the Third Party Software and Third Party Services in the twelve (12) months preceding a claim by the Reseller.

6. WARRANTY

- 6.1. The Third Party Services are all provided on an "as is", "with all faults" and "as available" basis. Supplier make no express warranties or guarantees about the Third Party Services or anything else. Supplier hereby disclaims and negates all other warranties.
- 6.2. SUPPLIER AND ITS LICENSORS AND SUPPLIERS MAKE NO WARRANTY THAT DEFECTS WILL BE CORRECTED OR THAT THE PRODUCTS: (I) WILL MEET RESELLER CLIENTS REQUIREMENTS; (II) WILL BE COMPATIBLE WITH RESELLER CLIENTS EQUIPMENT OR END USER EQUIPMENT; (III) WILL BE AVAILABLE ON AN UNINTERRUPTED, TIMELY, SECURE, OR ERROR-FREE BASIS; OR (IV) WILL BE ACCURATE OR RELIABLE. NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED BY RESELLER OR RESELLER CLIENT FROM SUPPLIER OR THOUGH THE THIRD PARTY SERVICES SHALL CREATE ANY WARRANTY.
- 6.7. WHEN RESELLER CLIENT INSTALLS, SETS-UP OR USES THE THIRD PARTY SERVICES RESELLER CLIENT MAY BE GIVEN THE OPPORTUNITY TO ALTER DEFAULTS OR CHOOSE PARTICULAR SETTINGS. THE CHOICES RESELLER CLIENT MAKES CAN CAUSE DAMAGE OR LEAD TO NON-RECOMMENDED OPERATION OF CUSTOMER'S EQUIPMENT OR RESELLER CLIENT'S SYSTEMS. 7. THIRD PARTY SOFTWARE LICENSE

- 7.1. Certain items of independent, third party code may be included in the Third Party Software that are subject to "open source software" e.g., the GNU General Public License, Lesser General Public License or other open source licenses (collectively, "Open Source Software"). The Open Source Software is licensed under the terms of the license that accompanies such Open Source Software. Nothing in this paragraph 7 limits Customer's rights under, or grants Customer rights that supersede, the terms and conditions of any applicable end user license for such Open Source Software. In particular, nothing in this paragraph 7 restricts Customer's right to copy, modify, and distribute such Open Source Software that is subject to the terms of the licensing accompanying such Open Source Software.
- 7.2. The License is terminable by Supplier and/or Third Party at any time. Unless explicitly provided otherwise in the License, under the License the Reseller Client may not:
 - 7.2.1. modify or copy the Third Party Software;
 - 7.2.2. use the Third Party Software for any commercial purpose not described in this Contract or on www.callcabinet.com, or for any public display (commercial or non-commercial);
 - 7.2.3. attempt to decompile or reverse engineer the Third Party Software;
 - 7.2.4. take any action which may cause the Third Party Software, or any portion thereof, to be subjected to the terms of any additional Open Source Software licensing.
 - 7.2.5. remove any copyright or other proprietary notations from the Third Party Software; or
 - 7.2.6. transfer the Third Party Software to another person or "mirror" the Third Party Software on any other server, without Supplier's written consent.
- 7.3. The License may be amended, modified or revoked by Supplier and/or Third Party at any time as provided in this Contract. The License will automatically terminate if (i) the Reseller or Reseller Client breaches the terms of this License; or, (ii) if the Reseller Client user account is closed or terminated for any reason.

- 7.4. The Reseller Client's permission to use the Third Party Software is conditioned upon the Resellers agreement with Supplier that the Reseller Client:
 - 7.4.1. will comply with this License;
 - 7.4.2. is solely responsible for the secrecy and security of the Reseller Client user account credentials and any activity that occurs in the Reseller Client user account; and
 - 7.4.3. is solely responsible for the Reseller Client compliance with all Applicable Laws and maintaining the privacy rights of the Reseller Client customers or other parties being recorded using the Third Party Software.

8. CONFIDENTIAL INFORMATION

Confidential Information provided in respect of Third Party Services shall be subject to the confidentiality obligations as set out at clauses 14.7 – 14.13 inclusive of the Conditions save that such confidentiality obligations shall survive for five (5) years beyond the expiration, non-renewal or termination of the receipt of Third Party Services under this Appendix.

9. COMPLIANCE WITH LAWS

The Reseller agrees to comply with all Applicable Laws and hereby agrees to indemnify and hold Supplier harmless against any claim for loss, damage, cost, expenses injury or death to Supplier and/or third parties caused by the Reseller Client failure to comply with any such Applicable Laws.
